IMPORTANT INFORMATION

1. All games will be played at Memorial Park (Mary Avenue and Stevens Creek Boulevard).
2. Game time is forfeit time. Teams will be fined **\$20** for the first forfeit and **\$60** for each forfeit thereafter.
3. Any player ejected for any reason will be suspended for at least the next scheduled game.
4. No metal-spiked shoes may be worn; synthetic or rubber-spiked shoes are permissible.
5. All games have a 70-minute time limit, except the Championship game. After five innings a 12-run rule will be in effect.
6. All players must have signed the Player Contract Form prior to participating in any league games. Failure to do so will result in a forfeit.
7. Last day to add/drop is prior to the start of the **sixth** game of the season.
8. Team listed last is home team and will occupy the first base dugout.
9. **NO SMOKING** and **NO ALCOHOLIC BEVERAGES** are allowed in or around the softball/tennis court complex. Managers are responsible for enforcement with players and spectators.
10. There will be a two home run limit per game per team.
11. Any postponed games will be made up at the end of the scheduled season.
12. Teams that qualify for the playoffs must use the players listed during the season in the playoffs. In order for a player to be eligible for playoff games, the player must have participated as a player in at least **five** games during the season.
13. Catcher's mask is required. Each team **MUST** supply their own mask.
14. RAIN OUTS: In the event of rain, call 777-3120 after 3:00 p.m. to determine status of scheduled games. After 5:00 p.m., call 777-3123 for a recording on status of games.
15. Finalized lineups are due to the scorekeeper at least **10** minutes before game time.
